This information notice on the use of cookies (hereinafter the "Cookie notice") has been drawn up to inform you about the cookies that SOFICO, a public legal entity with headquarters at Rue du Canal de l'Ourthe 9/3, 4031 Angleur, Belgium, registered with the Banque Carrefour des Entreprises under number 0252.151.302 (acting as data controller and hereinafter referred to as "we, us or our", depending on the case) uses via this website (hereinafter, the "Website").

1. INTRODUCTION

Through this Notice, we would like to inform you about how we use cookies.

2. GENERAL INFORMATION ABOUT COOKIES

Cookies are small electronic text files placed in the browser of your computer (or another digital device used) by the websites that you visit. They are generally used to enable websites to operate or to operate more effectively, as well as to provide information to website owners.

When you visit this Website for the first time, the home page will inform you of this Website's use of cookies and how to consent to their use, via a "cookie banner".
